**Finance & Administration Manager** -- Leads and directs program's financial, operational, and administrative functions. Develops and tracks budgets, manages payroll and vendor relations, and controls all financial transactions and reporting. Responsible for sub-award contracting, procurement, financial reporting, and HR. **Qualification Requirements:** Bachelors Degree (minimum) or Masters Degree (preferred) in Business, Finance, or Accounting. 6+ years managing financial and contractual aspects of large, complex development programs (preferably USAID). Significant experience developing and managing large budgets and grants programs, procurement and contracting. Deep knowledge of US Government Cost Accounting Standards, FARs, and AIDARs.

**Vector Control Manager** -- Manages all Zika vector control field activities, including environmental management, larviciding, health education and outreach. Supervises technical implementation staff and Department Coordinators. Recruits and trains seasonal field workers. Coordinates with local government stakeholders. Determines types and quantities of materials and supplies needed for vector control in the country. **Qualification Requirements:** Masters Degree in Entomology, Public Health, or Environmental Health, and 6+ years of experience in vector control, entomological surveillance, and the regulatory and operational aspects of insecticide use and management.

**Entomological Monitoring Manager** -- Provides leadership and management oversight to all of the project's entomological surveillance activities and guides key technical strategy decisions based on data analysis and interpretation. Recruits and trains seasonal entomological technicians. Determines types and quantities of materials and supplies needed for entomological surveillance in the country. **Qualification**

**Requirements:** Masters Degree in Medical Entomology and 6+ years of entomological monitoring and vector control management, including the control of *Aedes* mosquitoes. Experience in Dengue and Chikungunya vector control in Latin America is an advantage.

**Environmental Compliance Officer** -- Responsible for ensuring program compliance with US Government and Government of operation environmental regulations. Performs environmental compliance assessments. Tracks status of insecticides at storage facilities, during transportation and at operational field sites. Oversees waste management activities. **Qualification Requirements:** Masters Degree in Environmental Science, Environmental Engineering, or Environmental Health, and 6+ years of relevant professional experience, including experience in environmental compliance and insecticide use and management.
